APPLICATION RATE RECOMMENDATIONS

THATCHzyme™ spray can be applied to golf course™ turf, sports turf, sod, residential lawns, and garden landscaping. Apply only as directed.

Warm and Cool Season Turf: Mix well before use. Apply 0.4 ounces per 1,000 sq. ft. in 2 gallons of water biweekly or 0.8 ounces per 1,000 sq. ft. in 2 gallons of water monthly. For best results THATCHzyme spray should be watered in to the thatch layer and applied throughout the growing season.
